> (i) To consider the request dated 26.06.2020 of Shri N.P.Singh, former Controller of Examination of the university regarding retention of Staff Quarters No.Type-V/5 due to COVID-19

> The Executive Council considered the letter dated 26.06.2020 and also noted the contents of the agenda item. Accordingly, it was observed that Shri N.P.Singh was superannuated on the post of Controller of Examination of the Vidyapeetha on 31.01.2020. Under Rule-15(ii) of the Bye-Laws Governing the Allotment of Residential Accommodations", 2011 as amended from time to time, he has retained the Staff Quarters No. Type-5/5 on payment of license fee i.e. two months on normal license fee and another two months on double the normal license fee till 31.05.2020. Subsequently, he was allowed to retain the Staff Quarters till 30.06.2020 as per the guidelines issued by the M/o. Housing & Urban Affiars vide their Office Memorandum dated 25.03.2020 and 05.05.2020 on normal licence fee on account of COVID-19.

> There was complete lockdown in the country from 23,03,2020 to 31.05,2020 and all the activities were prohibited except essential astivities on account of COVID-19. During this period, he could move from the allotted house of the campus as VERIFIED per the factual position given above.

This decision should not be taken as precedent in any other case.
