The Chairperson extended a warm welcome to the members present in the meeting. Prof. Harihar Trivedi, Member of the BoM performed Manglacharan. Subsequently, the following agenda items were taken up for consideration:

Item No. 15.1 To consider the minutes of the 14th meeting of the Board of Management held on 30.08.2016 for confirmation.

The Board of Management considered its minutes of the 14th meeting held on 30.08.2016. It was noted that no discrepancies have been pointed out by any of the members within the stipulated period of time. Therefore, *it was resolved to confirm the minutes of the 14th meeting in toto.*

Item No.15.2 To consider and adopt the Secretary's Report regarding the action taken on the minutes of the 14th meeting held on 30.08.2016

The Board of Management *resolved to note the Secretary's Report on the action taken on the 14th meeting of the Board of Management held on 30.08.2016.*

Item No.15.3 To consider and approve the minutes of the 8th meeting of the Finance Committee held on 16.12.2016.

The Board of Management considered the minutes of the 8th meeting of the Finance Committee held on 16.12.2016 and *it was resolved to approve the minutes of the 8th meeting of the Finance Committee dated 16.12.2016 in toto.*

Item No.15.4 (i) To consider the minutes of the 2nd meeting of the Planning & Monitoring Board held on 8.12.2016, (ii) meeting of the IQAC held on 08.12.2016 and (iii) the 6th meeting of the Academic Council held on 20 12.2016.

The Board of Management considered the minutes of the 2nd and the 6th meeting of the Planning & Monitoring Board, IQAC and the Academic Council held on 8.12.2016 and 20.12.2016 respectively and *it was resolved to approve the minutes of the 2nd meeting of the Planning & Monitoring Board dated 8.12.2016, meeting of the IQAC held on 8.12.2016 and the 6th meeting of the Academic Council dated 20.12.2016 in toto.*

Item No.15.5 To consider and approve the draft Memorandum of Association of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi

Board of Management noted that during 2015, the draft Memorandum of Association duly approved by it was submitted to the Ministry of HRD for approval of the Governing Body of the Vidyapeetha. Before approval of the Governing Body was accorded, the UGC issued the amendment to UGC (Institution Deemed to be Universities) Regulations, 2010 due to which the UGC and the Ministry of HRD, Government of India vide their office letters No.1-3/2016 (CPP-1/DU) dated 21.7.2016 and No.5-2/2014-Skt.I dated 15.9.2016 respectively, advised the Vidyapeetha to amend/modify the Memorandum of Association keeping in view the latest provisions of the UGC (Institution Deemed to be Universities) Regulations, 2016. Accordingly, in accordance with the resolution no. 13.7 dated 22.7.2016 of the Board of Management, a Committee duly constituted by the Vice-Chancellor at its meetings held on 23rd & 24th September, 2016 reviewed and suggested necessary changes in the Memorandum of Association in accordance with the provisions given under the UGC (Institution Deemed to be Universities) Regulations, 2016, keeping in view of the functional requirement of the Vidyapeetha.

Subsequently, the Board of Management considered the draft Memorandum of Association and *it was resolved that the draft Memorandum of Association of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha as recommended by the Committee at its meeting dated 23rd & 24th September, 2016 be approved with the following additions:*

"The following provision be made under Rule-3 (i) & Rule-16 relating constitution of the Board of Management & Finance Committee respectively of the Vidyapeetha:

Pro-Vice-Chancellor or the Nominee of the Chancellor as the case may be."

It was further resolved that draft Memorandum of Association be submitted to the Governing Body of the Vidyapeetha for its endorsement after which the draft Memorandum of Association be sent to the UGC for approval. On completion of all the desired procedural formalities, the Memorandum of Association be registered with the office of the Registrar of Societies under the Societies Registration Act, 1860.

It was further resolved to confirm the decision on the table for implementation.

Item No.15.6 To consider the advice of the UGC on legality of the alleged irregular appointment of the teachers of the Vidyapeetha [Report(s) dated 27.03.2016 and 22.05.2016 of the Inquiry Committee] along with other cases.

(A) Prof. Harihar Trivedi, member of the BoM recused himself from the discussion and decision making process as his name was figuring in the list of the alleged irregularly- appointed teachers. The Board of Management noted that in accordance with the resolution No. 13.8 dated 22.7.2016 of the Board of Management, the Reports dated 28.1.2016, 27.03.2016 and 22.05.2016 of the Inquiry Committee along with all the related documents/reports/resolutions etc. were forwarded to the University Grants Commission vide this office F.No. LBSV/ REG/101/BOM-13/2016/ dated 1.8.2016 to advise the legality of the appointments of 19 teachers of the Vidyapeetha.

The UGC constituted a Committee consisting the UGC Officers, UGC Panel Advocate along with subject expert to examine the matter. The Committee considered the Report(s) dated 28.1.2016, 27.03.2016 and 22.05.2016 of the Inquiry Committee along with all related information and documents provided by the Vidyapeetha and the earlier report of the one man Inquiry Committee dated 07.04.2008 of Prof. D. Prahaldchar, Ex-Vice-Chancellor of Rashtriya Sanskrit Vidyapeetha duly constituted by the UGC as per the dated 30.5.2007 of the Hon'ble High Court in the Civil Writ Petition No.4334/2007 was filed by Indian Council of Legal Aids Vs. Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha & others, keeping in view the extant UGC Regulations as applicable at the time of appointment of these teachers. After examining the legality of the appointments of the teachers in question, the UGC vide

letter No F.7-4/2016 (DU) dated 4th November, 2016 forwarded its report on this matter to the Vidyapeetha. As per the report, out of 19 cases, the under-mentioned 17 cases of teachers have been found to be in order:-

After careful consideration, the Board of Management being the competent disciplinary authority under Rule-4 (ix) read with Clause-4.4(viii) of the UGC (Institutions Deemed to be Universities) Regulations, 2010 resolved to rely on the Report of the UGC Committee duly approved by the competent authority of the UGC and communicated to the Vidyapeetha vide their letter No F.7-4/2016(DU) dated 4th November, 2016 in respect of all the 19 teachers.

It was further resolved that the Report(s) dated 28.1.2016, 27.03.2016 and 22.05.2016 of the Inquiry Committee in respect of 17 teachers as stated above be accepted strictly based on the observations of the UGC as communicated vide UGC letter No F.7-4/2016(DU) dated 4th November, 2016.

Consequently, it was resolved that the following 17 teachers be exonerated of all the charges as framed against them as per their respective charge-sheet. The decision of the Board of Management be communicated to the Standing Counsel of the Vidyapeetha and all concerned teachers at the earliest.

As regards the remaining two cases given below, the Board of Management noted the following observations of the UGC:

After careful consideration of the two cases mentioned above, the Board of Management resolved that:

(i) In view of the report of the UGC dated 4th November, 2016 in case of Dr.Yashveer Singh, the relevant portions of the observations of the UGC's letter No F.7-4/2016(DU) dated 4th November, 2016 along with the relevant extracts of the report of the Enquiry Committee pertaining to Dr. Yashveer Singh be provided to him for his written submission in his defence, and his case along with his submissions, if any be placed before the Board of Management at its next meeting for appropriate decision.

(ii) In view of the report of the UGC dated 4th November, 2016 in case of Dr Sadan Singh, the relevant portions of the observations of the UGC's letter No F.7-4/2016(DU) dated 4th November, 2016 along with the relevant extracts of the report of the Enquiry Committee pertaining to Dr. Sadan Singh be provided to him for his written submission in his defence, and his case along with his submissions, if any be placed before the Board of Management at its next meeting for appropriate decision.

(B) In addition to the above, the BoM noted that in accordance with the resolution No.13.8 dated 22.7.2016, Dr. Neelam Thagela, Assistant Professor (Jyotish) was asked to get her name published in the Gazette of India as per due procedures. Accordingly, she has published her name in the Gazette of India on 23.09.2016. Since Dr. Neelam Thagela has complied with the condition of publication of her name in the Gazette of India, *the Board of Management resolved that Dr. Neelam Thagela be exonerated of the charges and consequently the recommendation of the Selection Committee kept in sealed cover relating to her promotion as Professor (Jyotish) was approved after opening the envelop for implementation. Accordingly, Dr. Neelam Thagela be promoted as Professor under CAS with effect from 31.07.2014.*

(C) As regards the Report of the Inquiry Committee dated 27.11.2016 in respect of Dr. Dev Dutt Chaturvedi, the Board of Management considered the sealed cover report dated 27.11.2016 of the Inquiry Committee for appropriate decision. After careful consideration, *the Board of Management resolved that the Inquiry Committee Report dated 27.11.2016 pertaining to Dr.Dev Dutt Chaturvedi be circulated to all the members of the Board of Management for their views and also to the UGC to examine the legality of the matter. The matter be placed before the next meeting of the BoM for appropriate decision at the earliest.*

(D) Regarding the Report dated 19.12.2016 of the Review Committee relating to the promotion cases of Dr. Dev Dutt Chaturvedi and Dr. Rashmi Mishra as Professor (Sahitya) under the CAS was thoroughly discussed and it was resolved that *the Report of the Review Committee dated 19.12.2016 in the matter of Dr. Dev Dutt Chaturvedi and Dr. Rashmi Mishra with all relevant documents, API scores and relevant publications be sent to the UGC to examine the legality of the matter. As soon as the report of the UGC is received, these two cases along with all relevant documents/file be placed before the Board of Management for an appropriate decision in this regard.*

It was further resolved to confirm the decision on the table for implementation.

Item No.15.7 To consider the report of the Preliminary Inquiry Committee constituted by the Board of Management on the complaint dated 19.07.2016 of Dr. Devendra Prasad Mishra, Assistant Professor (Veda) making allegations against Dr. Sunder Narain Jha on his appointment as Associate Professor (Veda).

The BoM noted that in accordance with Resolution No. 14.7 dated 30.08.2016 of the Board of Management, a Preliminary Inquiry Committee in the nature of fact finding under the Chairmanship of Prof. B.B. Goel, former Professor, Punjab University, Chandigarh was constituted to inquire into the allegations made in the complaint dated 19.07.2016 of Dr. Devendra Prasad Mishra, Assistant Professor (Veda) against Dr. Sunder Narain Jha, Assistant Professor (Veda) of the Vidyapeetha. Prof. B.B.Goel submitted the report on 3rd November, 2016 with suggestion to scrap the selection process for the post of Associate Professor (Veda) to safeguard the transparency, fair play and eventuality of any legal hassles. After careful consideration, *the BoM resolved that the Report dated 03.11.2016 of the Preliminary Inquiry Committee headed by Prof. B.B.Goel be accepted and the recommendation of the Selection Committee dated 13.07.2016 regarding appointment of Dr. Sunder Narayan Jha on the post of Associate Professor (Veda) be referred to the Chancellor of the Vidyapeetha under Rule-26(c) of the Memorandum of Association for final orders.*

Item No.15.8 To consider and ratifying the decision of the Vice-Chancellor and decide the mode of recovery of Rs. 25000/-from Prof Bhaskar Mishra, the Ex-Vice-Chancellor (I/C) of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeeth pursuant to the MHRD Letter No. F.No.1-11/2014-skt.1, dated 20th October, 2016.

The Board of Management after perusing the letters dated 4.7.2016 and 6.10.2016 of the National Human Rights Commission noted that Prof Bhaskar Mishra, the then Vice-Chancellor (i/c) was directed by the Vice-Chancellor of the Vidyapeetha vide letter No.F.1(115)/2016/LBSV/1673 dated 2.11.2016 to pay Rs 25,000/- latest by 10th Nov, 2016 to Dr BK Mohapatra, former Registrar and report compliance to the Vice-Chancellor, SLBSRSV for onward transmission to the Ministry of Human Resource Development, Govt. of India and National Human Rights Commission. Prof Bhaskar Mishra instead of complying with the directive of the Vice-Chancellor submitted a representation dated 9.11.2016 to the Secretary of the Ministry of Human Resource Development, Govt. of India and a copy of the said representation to the National Human Rights Commission, with a request to grant him relief on this account.

The Vidyapeetha in order to comply with the orders of the National Human Rights Commission and the directive of the MHRD communicated vide their letter no. F. No.1-11/2014-Skt.I dated 20th Oct 2016, being the State under Article 12 of the Constitution of India, issued an office order No.F.1/LBSV/Admn/2016-17/1875 dated 21 Nov 2016 to release the payment of Rs 25,000/- to Dr BK Mohapatra. Accordingly, payment of Rs.25,000/- was made to Dr. BK Mohapatra and compliance report was sent to the Ministry and the National Human Rights Commission vide letter No.F.1/LBSV/Admn/2016-17/1892 dated 21 Nov 2016.

The Board of Management observed that Prof Bhaskar Mishra appears to be in agreement with the orders of the NHRC which is apparent from his representation dated 09.11.2016. It was also observed that the Vidyapeetha has rightly discharged its liability by releasing the payment of Rs.25000/- within the stipulated time as per the orders of the NHRC. But in the same order, the NHRC has also observed that the Vidyapeetha could recover the entire amount from the delinquent official Prof. Bhaskar Mishra, the then In-charge Vice-Chancellor for violation of Human Rights.

Further, it was also noted that Prof. Bhaskar Mishra did not produce any order from the NHRC or from any competent court staying the operation of the order of the NHRC. Therefore, the plea of Prof. Bhaskar Mishra has no base and does not deserve any consideration at this stage. Moreover, it does not appear to be justified on the part of the state to incur expenses out of public funds for its employee for committing willful transgression of authority or acting contrary to the dictate of Law with malafide intention. Therefore, the reply

furnished by Prof. Bhaskar Mishra has no merit and his request for withdrawal of Show-Cause Notice be not acceded to. Since the action of Prof. Bhaskar Mishra has been treated as malafide and unlawful by the BOM as per resolution no.3.(ii) dated 23.12.2014 and there appears to be a willful violation of rules by him, the contentions of Bhaskar Mishra stand on a weak foundation. *After careful consideration, the Board of Management resolved to ratify the Orders dated 18.11.2016 of the Vice-Chancellor regarding payment of compensation Rs. 25,000/- to Dr.BK Mohapatra, former Registrar of the Vidyapeetha. It was further resolved that Rs.25000/- be recovered from the salary of Prof. Bhaskar Mishra under intimation of all concerned. In case Prof. Bhaskar Mishra get any relief from the NHRC regarding payment of compensation of Rs. 25000/- to Dr. BK Mohapatra, the Vidyapeetha should follow the directive of the NHRC accordingly.*

Item No.15.9 To consider and decide the action to be taken against Prof. Bhaskar Mishra as per the instruction issued vide letter F.No.1-11/2014-Skt.I dated 22.11.2016 of the Ministry of HRD, Govt. of India.

The Board of Management noted that Prof. Bhaskar Mishra submitted a representation dated 09.11.2016 to the Secretary, Ministry of HRD, Govt. of India without adhering to the procedures as per the guidelines of the contained in the OM No.11013/08/2013- Estt. (A.III) dated 6.6.2013 which were duly communicated by the Ministry of HRD, vide letter No.3-2/2011.I (Vol.II) dated 15.5.2014. While doing so Prof. Bhaskar Mishra also used the official letterhead of the Vidyapeeth despite the fact that it was his personal representation. Consequently, the Ministry of HRD vide letter F.No.1-11/2014-Skt.I dated 22.11.2016 while taking a view in the matter issued a directive to place the matter before the Board of Management for initiating action under intimation to the Ministry of HRD. In response to the Show Cause Notice No. F.1 (115)/LBSV/Admn./HR/2016/2069 dated 7.12.2016, the reply dated 15.12.2016 submitted by Prof. Bhaskar Mishra does not appear to have any relevance to the context. However, the Board of Management taken a lenient view in the matter and *resolved that Prof. Bhaskar Mishra, Professor (Education) be advised to follow the CCS (Conduct) Rules, 1964 in letter and spirit.*

Item No.15.10 To report the Orders/Notifications issued with the approval of the Vice-Chancellor of SLBSRSV, New Delhi

The Board of Management noted the different Orders of the Vice-Chancellor with regard to day to day functioning of the Vidyapeetha as under:-


