



**ITEM NO. 2.3 To consider and approve the Budget Estimates 2021-2022 of Shri Lal Bahadur Shastri National Sanskrit University.**

The Finance Committee examined the Budget Proposal of Shri Lal Bahadur Shastri National Sanskrit University for the financial year 2021-2022. The Finance Committee was informed that Non-Salary Grant (Budget Head 31) has not been provided to the University during the Financial year 2019-2020 and 2020-2021 till date resulting in the financial hardship and difficulty in operation of day to day affairs of the University.

After a detailed discussion, the Finance Committee Resolved to approve the Budget Estimates 2021-2022 of Shri Lal Bahadur Shastri National Sanskrit University.

**ITEM NO. 2.4 To consider and approve the Separate Audit Report of the Comptroller and Auditor General of India on the Annual Accounts 2019-2020.**

The Finance Committee discussed the Audit Report (SAR 2019-2020) issued by the Director General of Audit (Home, Education and Skill Development), I.P. Estate, New Delhi. The Finance Committee advised that observations contained in the SAR 2019-2020 should be complied with at the earliest and Resolved to approve SAR 2019-2020

To consider and approve the Delegation of Financial and Administrative Powers of Shri Lal Bahadur Shastri National Sanskrit University to its officers.


