ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeeth, Katwaria Sarai, New Delhi – 110016 vide Order No. F. NRC/NCTE/F-3/DL-65/1998/4311-13 dated 18.11.1998 for B.Ed. course of one year duration with annual intake of 180 students followed by order F.No./F-3/DH-10/B.Ed./5277-84 dated 31.07.2000.

AND WHEREAS, permission was granted by the Northern Regional Committee to Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeeth, Katwaria Sarai, New Delhi – 110016, vide Order No. F. NRC/NCTE/F-3/DH-309/2004/9059-9067 dated 16.08.2005 for M.Ed. course of one year duration with an annual intake of 25 students.

AND WHEREAS, revised recognition order was issued vide No. F. No./NRC/NCTE/DH-65/2015/11226-31 dated 05.06.2015 for conducting B.Ed. course of two years duration with an intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

AND WHEREAS, revised recognition order was issued vide No. F. No./NRC/NCTE/DH-309/2015/113983-989 dated 06.06.2015 for conducting M.Ed. course of two years duration with an intake of 50 students (one basic unit of 50 students) from the academic session 2015-2016.

AND WHEREAS, the institution has made request vide letter dated 20.07.2020 for change of its name, which was considered by the NRC in its 315th Meeting (virtual) held on 17th & 20th August, 2020 and the Committee decided as under:-


