The Executive Council observed that the constitution of the first Court, term of appointment of members of the Court is required under Clause-10 of the Statutes of the University. In this regard, the relevant provisions have been prepared by the Expert Committee based on the pattern adopted by other Central Universities and may be added under Clause-10 of the statutes after the approval of the Central Government. Further as per the directive of the UGC, the provision of the nominee of the UGC in the Finance Committee is required to be inserted under Clause-19 of the Statutes of the University. In addition to the above, the provision of remaining officers is proposed by the Expert Committee in the Statute under Section 9 (8) of the Central Sanskrit Universities Act, 2020.

After going through the relevant provisions of the Central Sanskrit Universities Act, 2020 and report dated 30.12.2021 of the Expert Committee, the Executive Council resolved that the Item No.1 and 2 of the Report dated 30.12.2021 of the Expert Committee as referred above pertaining to composition, term of appointment of members of the Court and provision of nominee of the UGC be approved with a minor amendment in the proposed constitution of Court. In this regard, the Executive Council resolved that the provision of one eminent academician to be nominated by Chancellor be made at S.No.8 in the proposed constitution of Court instead of two eminent academicians proposed by the Expert Committee.

As regards the Item No.3 relating to provision of officers of the University, it was resolved that before approval of such proposal, the existence of proposed officers such as Dean Academic Affairs, Dean Student's Welfare, Director IQAC, Chief Proctor, Proctor, Chief Warden, Hostel Warden and Dean-Planning & Development be ascertained from other Central Universities. In this regard, the Vice-Chancellor be authorized to take further action at par with other central universities at the earliest. Finally, all the proposed amendments be submitted to the Hon'ble Visitor for his assent through the Ministry of Education under Clause-28 (3) of the Central Sanskrit Universities Act, 2020.

Item No.5.8

To consider and approve the panel of eminent persons for appointment of Chancellor by the Hon'ble Visitor of SLBSNSU, New Delhi

The Executive Council noted the contents of the agenda note and observed that the five years term of present Chancellor - Dr. Hari Gautam, Former Chairman of the University Grants Commission, New Delhi is going to complete on 03.05.2022. Accordingly, the Executive Council considered the matter relating to preparation of a panel of eminent persons in the academic or in public life of the country for appointment as Chancellor of the University. Subsequently, the Executive Council resolved to recommend the following panel to the Hon'ble Visitor for appointment as Chancellor of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi for a term of five years as per Clause-1(2) of the Statutes of the Central Sanskrit Universities Act, 2020:-

Item No.5.10

To consider and approve the proposal with regard to creation of teaching, non-teaching and semi-academic posts in SLBSNSU, New Delhi.

The Executive Council considered the proposal along with detailed justification with regard to creation of teaching, non-vocational academic, semi-academic and non-teaching posts keeping in view the recommendations given by the Finance Committee vide Resolution Nos.3.5 dated 20.08.2021 and No.4.2 dated 19.01.2022. Consequently, the Executive Council observed that the proposal relating to creations of the posts has been prepared based on the functional requirements and to fulfill the objectives of the University. The ratio as laid down by the University Grants Commission for teaching and non-teaching staff i.e. - 1:1.1 has been followed by the University. Thus, the proposal is justified and additional posts may be sanctioned. After going through the proposal along with justification as well as the recommendations of the Finance Committee, *the Executive Council resolved to approve the proposal with regard to creation of teaching, non-vocational academic, semi-academic and non-teaching posts in Shri Lal Bahadur Shastri National Sanskrit University, New Delhi as under:-*

The Executive Council noted that in accordance with the decision of the Karya Parishad (Executive Council) dated 11.12.2001 of the erstwhile Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University), New Delhi, the Library of the Vidyapeetha was named as "Mahamahopadhyay Padmashree Dr. Mandan Mishra Library". 




