Item No.7.7

To consider the placement of Faculty from the Academic Pay Level-12 to Level-13A and Level 13A to Level 14 under the Career Advancement Scheme

The Executive Council considered the matter and observed that Dr. Abhishek Tiwari, Assistant Professor of English (Level 12) is due for placement in the Level 13A, w.e.f. 03.03.2022 under Career Advancement Scheme of the UGC. The Assistant Professor (Selection Grade/Academic Level 12) is eligible for placement under the Career Advancement Scheme (CAS) to Associate Professor (Academic Level 13A) subject to fulfillment of conditions as prescribed under Clause 6.4- III of UGC Regulation 2018.

Dr. Abhishek Tiwari, Assistant Professors is fulfilling all the conditions except the S.No. 5 above i.e. **"Evidence of having guided at least one Ph.D candidate,"** The Executive Council observed that in Shri Lal Bahadur Shastri National Sanskrit University, there is no Master Course/Programme/ Ph.D course in the concerned subject. Therefore, Dr. Abhishek Tiwari is unable to meet out this condition. However, this condition is not applicable on College teachers under CAS as per clause no. 6.4 B (III) and (IV) of UGC regulation 2018.

The UGC vide its letter dated 02.02.2023 informed that "University should follow clause 6.4 C III of UGC Regulation on Minimum Qualification for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education 2018 which provides the criteria for promotion under CAS for Assistant Professor (Selection Grade/Academic Level 12) to Associate Professor (Academic Level 13A). Further, the UGC Regulations and its amendment issued from time to time are framed after detailed deliberation by the Expert Committee and in consultation with the Ministry of Education and are mandatory in nature and cannot be overlooked at any stage and all the Universities/ Institutions/Colleges have been advised to strictly comply with them without any deviation.

During the discussion, one of the members apprised of the Executive Council that before the establishment of this institution as Central University, the erstwhile SLBSRS Vidyapeetha was imparting study to the students in English subject equal to college level only and there were no Master Course/Programme/Ph.D courses in the concerned faculty. Therefore, there is a need to deal with this matter in such direction. *After going through the contents of agenda note and detailed deliberations, the Executive Council resolved that the Vice-Chancellor be authorized to constitute an Expert Committee to consider the matter keeping in view the above-mentioned observations and submit its recommendation to the Executive Council for an appropriate decision at the earliest.*

Item No.7.8

To report the Audit Para No 3 (OBS-263060 dated 17.08.2022) regarding promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader/ Associate Professor and Professor under Career Advancement Scheme

The Executive Council considered the matter and observed that the Office of the Director General of Audit (Central Expenditure) in its Inspection Report for the year 2016-22, has raised the Audit Para No-3 (OBS-263060 dated 17.08.2022) regarding promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader/Associate Professor and Professor under Career Advancement Scheme in the Vidyapeetha. The Audit has recommended that the promotion of Dr. A.S. Aravamudan may be made as per clarification of UGC and the salary arrears paid to Dr. A.S. Aravamudan may be reviewed on the basis of his promotion as per rule.

The Executive Council observed that Dr. A.S.Aravamudan had joined the service of the Vidyapeetha as Lecturer (Mimamsa) in the grade of Rs. 8000-275-13500 w.e.f. 10.04.2003. Before joining the service of the Vidyapeetha, Dr. Aravamudan was employed at Rajiv Gandhi Kendriya Sanskrit Vidyapeetha, Sringeri under the Rashtriya Sanskrit Sansthan as Lecturer (Rs.8000-13500) w.e.f. 22.10.1997 and Lecturer-Senior Scale (Rs.10000-325-15200) w.e.f. 22.10.2001.

For counting of past services, the UGC's Regulations- Clause No.8.0.0 provides that previous service, without any break as a Lecturer or equivalent, in a university, college, national laboratory, or other scientific organizations, e.g. CSIR, ICAR, DRDO, UGC, ICSSR, ICHR and as a UGC Research Scientist, should be counted for placement of Lecturer in Senior Scale/Selection Grade. As per the said provision, the past services rendered in the pay scale of Rs.8000-13500 and Rs.10000-15200 at previous organization were countable for placement in the senior scale (Rs.10000-325-15200) and Selection Grade (i.e. 12000-420-18300) respectively.

The case was referred to the UGC from time to time to clarify the exact date of placement in the Senior Scale as no specific date for placement was mentioned in the UGC Notification/Regulations.

The UGC vide their letter No.1-16(ii)/97(DU) dated 31.12.2007 informed that as the regular service rendered by an incumbent in any institution as Lecturer, may be taken into account for the placement in the Senior Scale/Selection Grade/Reader, if he/she fulfills the other eligibility conditions laid down in the afore-cited Clause of the UGC Notification, 1998. If any incumbent is covered under the above clause then his/her services may be taken into account for placement in the senior scale, otherwise he/she will be treated as afresh.

The UGC vide their letter No.17-4/13(PS)/Misc. dated 8th September, 2014 had also clarified that the matter was referred to the Internal Audit Section of UGC and it has been opined that the past services of Dr.A.S.Aravamudan may be taken into account for placement in higher scale.

In pursuance of the Resolution No.7.7 dated 19.05.2014 of the Board of Management, a Committee was constituted to examine the case of Dr. A.S. Aravamudan. After consideration of the case, the Committee at its meeting held on 17th September, 2014 resolved that since Dr.A.S.Aravamudan fulfilled the eligibility criteria as prescribed in the UGC's Regulations, 1998, he may be treated as Lecturer-Senior Scale w.e.f. 10.04.2003 i.e. the date of his joining of service as Lecturer in the Vidyapeetha. The subsequent promotions such as Reader, Associate Professor and Professor w.e.f. 22.10.2006, 22.10.2009 and 22.10.2012 respectively may also be considered under the Career Advancement Scheme subject to fulfillment of the conditions as laid down in the UGC's Regulations, 1998 and 2010.

The Board of Management at its Special meeting held on 23.12.2014 (vide Resolution No.3 (iv) accepted the recommendations of the Committee dated 17.09.2014. Since the Committee had taken the decision in favour of Dr. A.S. Aravamudan, necessary office orders were also issued by the Vidyapeetha on 11.02.2015 and Dr.A.S.Aravamudan was placed in the Lecture-senior scale (10000-325-15200) w.e.f. 10.04.2003 as per the approval of the Board of Management. While implementation of the above-mentioned office order, the Internal Audit of the Vidyapeetha vide note dated 08.07.2015 has questioned the jurisdiction of the internal committee. Meantime the clarification was again sought from the UGC (vide letter no. 1(217) LBSV/Admn/2003/2015/206 dated 12.08.2015) to clarify the exact date of his placement in the Lecturer (Senior Scale).

Accordingly, the University Grant Commission vide their letter dated 31.03.2016 and 01.04.2016 clarified that "The case of Dr A.S. Aravamudan's appointment in Shri Lal Bahadur Shastri National Sanskrit University has been re-examined in consultation with UGC Internal Audit Cell and to say that his appointment would be treated as afresh for the purpose of his placement in higher/senior scale. However he would get the benefit of pay protection. In view of the above the UGC letter of even number dated 08.09.2014 superseded.

The UGC in its Notification-1998 and Regulations-2010 has prescribed a specific provision to count previous service of a teacher, without any break as Lecturer/Assistant Professor/Associate Professor and Professor for appointment under direct recruitment and promotion also. Thus, the past services of Dr.A.S.Aravamudan cannot be ignored keeping in view the provisions as laid down in the UGC's Notification 1998 and UGC Regulations-2010 as amended from time to time.

Based on the legal opinion in the matter from the Standing Counsel, his case was again considered for promotion by the Vidyapeetha at its own level under Clause-8.00 of the UGC Notification, 1998 as referred above. Accordingly, based on the recommendations of the IQAC, the Selection Committee at its meeting held on 13.08.2019 has recommended the promotion of Dr. A.S. Aravamudan as Lecturer/Assistant Professor as Lecturer-Senior Scale (Rs.10000-325-15200) w.e.f. 10.04.2003 and Lecturer-Senior Scale to Reader in the pay scale of Rs 12000-18300 w.e.f. 22.10.2006 keeping in view of his past service rendered as Lecturer and Lecturer-Senior Scale from 22.10.1997 to 09.04.2003 at Rajiv Gandhi Kendriya Sanskrit Vidyapeetha, Sringeri Karnataka under the Rashtriya Sanskrit Sansthan (Central Sanskrit University). He was designated as Associate Professor w.e.f. 22.10.2009 i.e. after completion of three years of regular service as Reader as per the UGC Regulations, 2010. The above-mentioned recommendation of the Selection Committee were approved by the Board of Management vide resolution No. 23.5 dated 13.08.2019 subject to outcome of the Writ Petition No. 4059/2016.

Subsequently, based on the recommendations of the Screening-cum-Evaluation Committee dated 08.09.2019 followed by the approval of the Board of Management vide resolution No. 24.3 dated 17.09.2019, he was also promoted as Professor under the CAS from Academic Pay Level-13-A to Academic Pay Level-14 w.e.f. 22.10.2012. The above-mentioned promotions were made subject to outcome of the Writ Petitions No. 4059/2016.

After the approval, the necessary office orders were issued by the University and salary arrears as due was released accordingly. It is relevant to mention here that the grievance of the Petitioner – Dr.A.S.Aravamudan as raised in the Civil Writ Petition No.4059/2016 was addressed by the University. On the basis of above, he has withdrawn the writ petition in the Hon'ble High Court of Delhi.

In this regard, the Executive Council also considered the comments of the Ministry as communicated vide letter dated 30.06.2023 as under:-

It is observed that this issue has cropped up now on the basis of the CAG audit Para No.3 (OBS-263060 dated 17.08.2022) regarding promotion of Dr. A.S.Aravamudan and the same be made as per the UGC's clarification dated 31.03.2016 and 01.04.2016, as the Commission has specifically mentioned that Dr. A.S.Aravamudan's appointment will be treated as a fresh one. However, the University has taken a view and gave promotions to Dr. A.S.Aravamudan on its own under Clause-8.00 of the UGC notification 1998 and regulations, 2010 without referring the matter to UGC.

As per the normal procedure past services rendered without any break will be counted for all benefits and the date of initial appointment will be from the date of initial appointment irrespective of any mode. In support of this, there are several court orders. However, as the University has taken a suo moto action in providing relief to this person, it is suggested that the University may take up the matter with the UGC and seek clarification whether they have taken into consideration the provisions contained under clause 8.00 of their 1998 notification before conveying their clarifications vide their letters dated 31.03.2016 and 01.04.2016.

After going through the above-mentioned factual positions, the Executive Council resolved that a High Level Committee be constituted to assess the applicability of Clause-8.00 of the UGC notification 1998 and UGC Regulations, 2010 as amended from time to time in case of promotion of Dr.A.S.Aravamudan as Lecturer-Senior Scale, Reader, Associate Professor and Professor under Career Advancement Scheme of the UGC as under:-

Item No.7.10

To consider and approve the draft Ordinances and amendments in the Statutes of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi

The Executive Council considered the minutes of the Expert Committee dated 13.06.2023 and 27.6.2023 regarding the proposed draft Ordinances, Regulations and amendments in the Statutes of the University. It was also noted that the draft Ordinances and Regulations duly prepared and recommended by the Expert Committee have been considered by the Academic Council at its 7th meeting held on 19.06.2023 under Clause-29 (1) of Central Sanskrit Universities Act, 2020 and accordingly placed before the Executive Council for consideration and approval.

After detailed discussions and deliberations, *the Executive Council resolved that proposed draft Ordinance (25) and Regulations (02) of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi as proposed by the Expert Committee at its meetings held on 13.06.2023 and 27.06.2023 and recommended by the Academic Council be approved for implementation in the University with immediate effect keeping in view of the above-mentioned Clauses-39 (5) of the Statutes of the Central Sanskrit Universities Act, 2020. 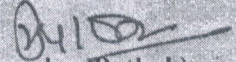
- (i) To consider the application of Prof. Ramesh Kumar Pandey, Professor, Department of Research relating to retention of Staff Quarters No. Type-V/4
