The Executive Council observed that against some teaching posts (like Professor in Paurohitya, Associate Professor in Vyakaran and Assistant Professor in Dharmashastra) only single candidate appeared before the Selection Committee for interview. After detailed discussion on the matter, the Executive Council decided not to open such sealed envelopes, carrying the recommendations of the Selection Committees (where only single candidate appeared for interview). Accordingly, the Council resolved that all such teaching posts or other similar posts be re-advertised.

The appointment on the abovementioned teaching posts be made subject to acceptance of the terms and conditions to be laid down in the offer of appointment letters, as issued by the University Administration, followed by the verification of the certificates of educational qualifications, experience or testimonials and caste (wherever applicable) etc., which were submitted by the selected candidates in support to their eligibility.

Further, it was resolved to advertise all the vacant teaching posts where the Screening Committees/ Selection Committees could not found eligible candidates for appointment as per the eligibility criteria prescribed in the UGC Regulations and advertisement of the post(s) concerned or where new vacancies have been arisen after the last advertisement of the University.

It was further resolved to confirm the decision on the table for implementation.
